



Operation In Our Sites

This domain name has been seized by ICE-Homeland Security Investigations, pursuant to a seizure warrant issued by a United States District Court under the authority of 18 U.S.C. §§ 981 and 2323.

Intentionally and knowingly trafficking in counterfeit goods is a federal crime that carries penalties for first time offenders of up to ten years in federal prison, a \$2,000,000 fine and restitution (18 U.S.C § 2320).

Operation In Our Sites-Project TransAtlantic IV is a coordinated effort by U.S. and European law enforcement agencies targeting websites and their operators that sell counterfeit goods.



Challenges

- Denial: "We don't see any problems!"
- Co-ordination
 - Commitment and deadlines
